Congratulations and thank you to everyone who played a part in the accreditation site visit at our new pediatric dental clinic on June 5. Given the challenges of establishing a new satellite academic program, we should all be very proud of the positive site visit results. The facility itself is outstanding of course. However our site visitors were more focused on the quality of the academic program, the outstanding faculty, both full-time and courtesy in Gainesville and Naples, the excellent staff and administrative support, and the great support from the Naples Children & Education Foundation (NCEF) and other community organizations. They were truly impressed by what we've been able to accomplish in a relatively brief period of time.

As you know, the site visit report must be reviewed by the CODA Review Committee and the full Commission, but the site visit team did not identify any deficiency that would result in a recommendation. or any status other that full "accreditation without reporting requirements." This is the highest rating offered by CODA. The successful site visit reflects your hard work and commitment to the program.
