
# Accreditation UP!Date

## What is CODA?

CODA is the Commission on Dental Accreditation and it's affiliated with the American Dental Association. CODA accredits dental schools and programs including D.M.D. and advanced dental education programs, and allied dental education programs in the U.S. CODA functions independently and autonomously in matters of developing and approving accreditation standards, making accreditation decisions on educational programs and developing and approving procedures that are used in the accreditation process.

# What is CODA Accreditation?

Our D.M.D. and specialty programs are currently accredited by CODA which is charged with ensuring that the nation's dental schools and programs maintain the highest professional and ethical standards. Every seven years, we have to have an accreditation site visit to ensure we continue to meet CODA standards. (Except for OMFS programs which are reviewed every five years.)

The school/program completes a comprehensive self study to evaluate how well they meet the standards that CODA sets. And then produces a self-study report detailing its resources, curriculum, policies and operational standards, as well as weaknesses identified and corrected as a result of the self-study.

The next step is an on-site review conducted by CODA team members selected for their expertise in the program area.

They conduct interviews with administrators, faculty, staff and students to verify information in the self-study and ensure that the program meets minimum accreditation standards.

The site visit team creates and submit a detailed report to the commission and the college/ program. The commission meets twice a year (usually January and July) to review site visit reports and make accreditation decisions.

### Why is accreditation important?

Graduating from an accredited program doesn't guarantee licensure or a successful career, it does reflect the quality of how a college or program conducts its business and speaks to a sense of public trust, as well as to professional quality.

#### For students

Accreditation provides assurance that the college you're attending is engaged in continuous quality improvement and that it meets national standards for the dental profession.

#### For faculty members

Accreditation provides a formal process for ongoing evaluation and improvement of our programs. It also provides a collaborative process for faculty, students and staff to evaluate how well we achieve our mission and advance the art and science of dentistry.



## What are the CODA standards for accreditation?

There are six CODA standards for pre-doctoral dental education programs.

Standard 1: Institutional Effectiveness Standard 2: Educational Program Standard 3: Faculty & Staff Standard 4: Educational Support Services Standard 5: Patient Care Services Standard 6: Research Program
