The rationale for this proposed change was presented at a recent Constitution Committee Meeting and unanimously approved.     </li> <li>Page 7. <i>SECTION 3 Faculty Committees, Subsection E</i>         Student Performance Evaluation Committee (SPEC)         This committee consists of six full-time faculty members elected by the Faculty Assembly, and one full-time faculty member appointed by the Dean, with two committee members elected each year. In addition, the committee includes three pre-doctoral students, one from the second, third, and fourth year classes. The Associate Dean for Academic Affairs will serve as the non-voting permanent Chair. In the event of a tie vote, the Associate Dean of Academic Affairs may cast the deciding vote. There is no Vice Chair. The Associate Dean for Student Advocacy and Inclusion and the Associate Dean of Clinical Affairs will serve as permanent, non-voting, ex officio members of the Committee. Members of this committee will also serve as the College's representatives to the HSC Conduct Committee and will be advised of conduct violations of students undergoing academic review by this committee. The committee reports directly to the Dean, who handles all appeals originating from the actions of the committee.</li> </ul>


